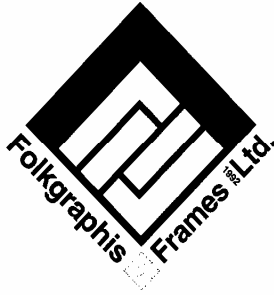

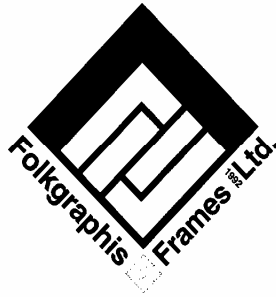

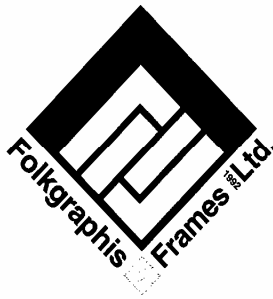

Canada's Personal Information Protection and Electronic Documents Act

Upon our request, you may provide us with personal information when you complete forms or contact us via telephone, mail, facsimile, e-mail or any other forms of communication. Folkgraphis Frames (1992) Ltd. complies with the following principles of Canada's Personal Information Protection and Electronic Documents Act:

Principle 1: Accountability - We responsibly protect and maintain your personal information.

Principle 2: Identifying Purposes - If your business entity is not incorporated the requested personal information provides us with the necessary details required to investigate and establish a credit approval decision plus fulfill administration requirements.

Principle 3: Consent - Your consent is required if we obtain, maintain, use, and disclose your personal information.

Principle 4: Limiting Collection - We will limit the personal information we collect at a level deemed necessary in order to provide your invoicing, credit, and collections needs.
